

## THE ANATOMY OF ELECTION FRAUD (2020 STYLE)

Analysis of Voter Rolls and Histories, and election data has shown the same pattern in **all states**.

- 1. Inflate Voter Rolls to provide a bank of available "phantom voters"
- 2. Massively increase availability of Mail-in/Absentee Ballots Print, Print, Print
- 3. Determine desired outcome percentage for the county
- 4. Drive election results to desired outcome in "real time" by adding appropriate mail-in ballots as needed (Early Voting = Perfect Polling)
- 5. Have backup plan ready just in case of a surprise (paper ballot dumps, etc.)
- 6. Clean up paper records (if necessary only done if audit suspected)
- 7. Clean up voter rolls to hide the initial inflation
- 8. Deny, Deny, Deny

### UTAH IS A MODEL OF ELECTION SECURITY AND INTEGRITY

As lieutenant governor, I am Utah's chief election officer. In that role, I oversee all elections in the state, although I do not run them. That is done at the local county and municipal level. For self-governance to work, citizens must trust the system, and I fear that trust in our free and fair elections is eroding.

I'm extremely concerned about any public official who deliberately cites pseudoscience and spreads conspiracies, who asks questions not because they seek answers, but wants to score political points by casting doubt on the system. These actions are dangerous and threaten to undermine the very foundations of our constitutional republic. Utah's politicians are using threats to try to prevent any investigation of the 2020 election.

Threats against Election Clerks. Threats against Citizens.

If Utah's elections are the "gold standard", permitting citizen investigation of the vote records and voter rolls will prove this.

Anything else will forever cast doubt upon the entire election process.

Currently, I am working with Rep. Jon Hawkins and county clerks from across the state to propose legislation that would establish additional election safeguards including audits of voter registration rolls, post-election audits that provide an independent review of the process, and improvements to the controls governing ballot processing.

After the 2018 election, then Utah Governor Herbert harshly criticized Utah County, referring to it as the "epicenter of dysfunction".


Were claims made at the time that Governor Herbert was jeopardizing our form of government? Especially as officials from Utah County immediately refuted these claims?

## UTAH VOTER REGISTRATION

While complete data is being withheld, the data that is available shows many problems with the data and the registration process.




Utah participates in a government program called "HAVV", which was established with the "Help America Vote Act".

This system is designed to register citizens who do not have appropriate ID to register normally. It checks the name, birthdate, and last 4 digits of the applicant's social security number against SSA records.

Evidence strongly suggests that this system is being used in many states to register ineligible voters.

## UTAH VOTER REGISTRATION

While complete data is being withheld, the data that is available shows many problems with the data and the registration process.




The Social Security Administration provides weekly statistics, per state, on the number of HAVV requests and their responses.

This chart shows that between September and November 2020, 20,126 checks of the HAVV system were performed in Utah (shown in green), and 3,356 of them did not match (shown in yellow). 28 were returned as matched but deceased.

In the week ending October 24<sup>th</sup> alone, 4,398 checks were performed, with 704 not matching.


Did 20,126 Utah citizens really attempt to register to vote without any state issued ID in this time period?

Did 3,356 residents of Utah really attempt to register to vote with incorrect personal identification?

How are these checks being performed, and what is the published procedure for dealing with a non-match?

The state and counties of Utah have repeatedly responded to GRAMA requests with incomplete, misleading data.

Utah claims that over 30% of voter registration data is held back because of privacy issues. It seems quite unlikely that more than half-million Utah citizens are either politicians, undercover policemen, in witness protection, or made the request to make their records private.

Other states give voters the right to protect their data. In no other state are the numbers anywhere close to the ones suggested by the state of Utah.

### UTAH VOTER ROLL ANALYSIS

The Voter Rolls which were obtained by a GRAMA request were incomplete, but still show serious issues.

### VOTER REGISTRATION

Voter registration is the gateway through which citizens pass in order to participate in elections. Utah uses a statewide voter registration database that is maintained by the Lt. Governor'. Voter rolls are rigorously maintained throughout the year to ensure that the list is accurate and up to date. Even with this limited data, many individuals were able to be identified as likely having multiple active voter registrations.

Analysis of the data provided allows the votes of the withheld voters to be calculated. The result is frequently precincts with up to 300% turnout, and county overvotes of tens of thousands. The conclusion is that the data being sent, or the data being reported, or possibly both, are not correct.

Shown here is an assertion from the Utah Lt. Governor in a recent publication designed to calm the citizens' election fears. If there is a statewide registration database, why were the counties reported with different field formats?

### UTAH VOTER ROLL ANALYSIS

The DS200 Tabulator has numerous documented vulnerabilities and is only EAC certified if the internal wireless modem is not installed



DS200 tabulators in numerous counties across the country have been found to have a wireless modem installed.

A DS200 in this condition can allow an outside attacker full access to the county election data.

All DS200 units need to be physically inspected for the existence of this serious vulnerability.

# Several Utah Counties showed troubling vote reports during the 2020 Election

All states report election returns to one of the reporting companies (for instance, Edison Research and Scytl) which are then relayed to the New York Times.

Analysis of these returns has provided evidence of vote manipulation in many states. Utah is one of them.

Four Utah counties, at some time during the election, are reported as *subtracting* vote totals. While a common response to this is to claim it was a correction of a human error in a previous report, the large number of incidences encountered nationwide makes this extremely unlikely. Additionally, it is often stated that these interim reports are "unofficial", however they are recorded in the data on the New York Times site, and the "corrections" had to initiate somewhere. If incorrect returns are being reported by the media, it stands to reason that the state would want to know why. Races are often called based upon these reports. **An analysis of the actual votes in these counties will provide an explanation.** 


Several Utah Counties showed troubling vote reports during the 2020 Election

Unitah	11/04/2020 3:29 AM	Approx. 10,000 votes switched from "In person" to "absentee"
Utah	11/11/2020 5:59 PM	2,999 votes removed from total with no change to any candidate

Switching in-person votes to absentee with different candidate selections is a suspected method of illicit vote manipulation.

As these are third-party reports, they must be compared against the specific county records to validate the true results.

Utah shows the same vote pattern as most other states




According to Edison Research and the New York Times, this graph shows how the votes for Donald Trump (light red) and Joe Biden (light blue) built over the course of the election.

The purple and orange vertical lines shows when the race was officially called in Utah and Florida (respectively).

This shows the actual vote counts reported as the counting continued, up until November 17<sup>th</sup>.

Utah shows the same vote pattern as most other states




At various times during the night of the election, all states show what is called the "Edison Zero". A zero count record is recorded in the Edison/New York Times data, and actual results are not reported for various amounts of times – sometimes seconds, sometimes hours, sometimes days.

In many "battleground" states, there is a correlation between this "Edison Zero" and the point at which counting stopped for a time.

The Edison Zero seems to be a signal to counties and states that their intended outcome changed after Florida was called for President Trump.

The Official Election Results show unusual percentages when compared



This chart compares the difference in winning percentage between President Trump, Governor Cox, and the combined U.S. House races.

President Trump received over 55,000 *less* votes than Governor Cox in the 2020 election.

Even when factoring in the heavily contested district 4 House race, the republican house candidates received almost 20,000 more votes than the President.


This does not match national trends.

### **Correlation Between Races**




Utah voters cast about 64,000 more votes for the presidential candidates than they did for the gubernatorial candidates.

However, President Trump received almost 55,000 less votes than Governor Cox.

The apparent preloading of Democrat votes can also be seen.

### Mesa County, Colorado 2020 Presidential Election




ORDROS ANALYTICS, INC Order from chaos Mesa County used only four tabulators for its 2020 election.

Tabulator 1 was the only "in person" tabulator, and it handled both early in-person and election day in-person ballots.

The votes on this tabulator started out about 3 to1 for Trump and ended up about 5 to 1.

Note what looks like a clear downward correction on Election Day.

### Mesa County, Colorado 2020 Presidential Election



Mesa County used only four tabulators for its 2020 election.

Tabulator 1 (Green) was the only "in person" tabulator, and it handled both early in-person and election day in-person ballots.


Tabulators 2, 3, and 4 (at bottom) were for mail-in ballots.

This graph shows the Trump to Biden ratio cumulatively throughout the early and mail-in periods.

### Mesa County, Colorado 2020 Election



Almost like magic, the very different tabulator counts combine to show a very "regular", almost linear chart.

The same pattern has been observed in over a dozen counties in ten states.

The pattern is observed no matter the relative percent of mail-in ballots.

### Mesa County, Colorado 2020 Election

About 25,000 of the 90,000 total ballots in the November 2020 General election in Mesa County were found to be manipulated and cannot be verified. This manipulation, triggered by an outside source, is undeniable.


The same methods were used to manipulate over 8,000 ballots in the 2021 Grand Rapids Municipal election. The "margin of uncertainty" caused by these votes are more than double the winning margin in all four of their city council races. All of these races had nearly unknown Democrat candidates apparently defeating popular Republican candidates.

These manipulations can only be detected by examining the election databases.



### Utah's use of a third party, partisan-funded registration consortium opens the state up to risk

Utah participates in ERIC (Electronic Registration Information Center).



ERIC has been controversial because of recent reports of security and confidentiality issues.

Kyle Ardoin, the Secretary of State of Louisiana, has cancelled Louisiana's contract with ERIC because of significant evidence of questionable funding and that partisan individuals may have had network access to data that could have been used inappropriately.

Other states are considering discontinuation of their contracts with ERIC.

Although an audit of all Utah counties is needed to assure that the 2020 Election was executed fairly, a data examination can focus future effort and resources

**Complete voter rolls and histories** can be used to confirm or deny the existence of "phantom voters" in the system. The roll must be the one which was active during the 2020 Election and the history must include all voters who voted in the 2020 Election. Any privacy concerns can be solved through an agreement by the examining party not to publicly disclose any personal voter information.

**Complete Cast Vote Records** from the ES&S systems of all counties showing all ballots received and the votes on that ballot will confirm or deny many types of artificial manipulation of the votes.

All of this information should via available pursuant to the Federal Election Retention Requirements. This initial analysis can be performed with very little cost to the county.



### THE PATH TO FAIR ELECTIONS

The 2020 election exposed numerous vulnerabilities that will be used in future elections if drastic changes are not enacted nationwide.

- 1. Require modern data "best practices" for all voter registration databases.
- 2. Eliminate third party or centralized registration processes.
- 3. State issued ID required for registration. All states supply free ID upon request and validation
- 4. Eliminate mail-in ballots. Allow absentee ballots only with proof of need.
- 5. Universal use of paper ballots, with modern security measures and unique numbers (like bank checks)
- 6. All ballots hand counted at precinct-level, totals delivered to County via secure couriers
- 7. Voting limited to two consecutive days, the traditional Tuesday and the previous or next day
- 8. The two-day election period must be state and federal holidays

Depending upon the poll, between 40% and 60% of Americans believe there was fraud in the 2020 Election. Analysis shows that this number is increasing over time.

This is a higher percentage than the number of American Colonists who supported rebelling against England.

Those who we entrust with our elections have a duty to restore confidence in our elections.
